**IMPORTANT NOTES:**

1. Candidates can apply only Online for TGTET-June-2026 to be held Online as Computer Based Test (CBT) between 15.06.2026 and 30.06.2026 through website <https://schooledu.telangana.gov.in> from 15.04.2026 to 30.04.2026.
2. Steps to be followed for submission of application Online.
  - a) The candidates shall first download the 'Information Bulletin' free of cost from the TGTET website <https://schooledu.telangana.gov.in>, go through it carefully and verify their eligibility for appearing for TGTET-June-2026.
  - b) The candidate after satisfying herself/himself about the eligibility criteria for TGTET, General & BC candidates shall pay a fee of 750.00 (Rupees Seven Hundred and Fifty only) if appearing for a single paper (i.e., only Paper I or only Paper II) or Rs.1000/- (Rupees One Thousand only) if appearing for Both Papers (i.e., Paper I and Paper II). SC / ST / PwD candidates shall pay a fee of Rs.700/- for one paper and Rs.950/- for two papers.
  - c) Candidate can pay the Fee through Online payment options provided on the website <https://schooledu.telangana.gov.in> between 15.04.2026 and 30.04.2026. At the time of Online Payment, the candidate has to give the required preliminary data (i.e. Name of the candidate, Date of Birth, whether the candidate belongs to Telangana, mobile phone number etc.). On receipt of online fee payment, the candidate shall be issued a 'Journal Number' with which she/he can proceed with submission of application online. Issue of Journal Number does not mean that the candidate has completed submission of application online. It is only a confirmation of the fee received.
  - d) The candidates shall follow the procedure for submission of online application as given in the 'Information Bulletin' and instructions provided online, while filling up the online application form.
  - e) The Candidate should be ready with scanned copy of the photograph of 500kb and Signature of 100kb before filling in the Online application.

- f) Applications with no photo and signature / unclear photo and signature/ inadequate size photograph will be rejected. Hall Ticket will not be issued to such candidates. Hence, after pressing the 'UPLOAD' button, check if the photo and signature is of required size, clear and is of the same candidate whose details are to be filled in the application. If the photo and signature is smaller in size, not clear or does not belong to the candidate, press 'UPLOAD' button below the photograph on the application form and restart with scanning of the photograph.
- g) Complaints relating to mismatch of photograph and / or candidate details will not be accepted after submission of application at any cost.

#### 4. TGTET - BACKGROUND AND RATIONALE

- i. The implementation of the Right of Children to Free and Compulsory Education (RTE) Act, 2009 requires the recruitment of a large number of teachers across the country in a time bound manner. In spite of the enormity of the task, it is desirable to ensure that quality requirement for recruitment of teachers is not diluted at any cost. It is therefore necessary to ensure that persons recruited as teachers possess the essential aptitude and ability to meet the challenges of teaching at the Elementary level Classes (I to VIII).
- ii. In accordance with the provisions of Sub-section (1) of Section 23 of the RTE Act, the National Council for Teacher Education (NCTE) had vide Notification dated 23<sup>rd</sup> August, 2010 laid down the minimum qualifications for a person to be eligible for appointment as a teacher in classes I to VIII. It had been inter alia provided that one of the essential qualifications for a person to be eligible for appointment as a teacher in any of the schools referred to, in clause (n) of Section 2 of the RTE Act is that she/he should pass the Teacher Eligibility Test (TET) which will be conducted by the appropriate Government in accordance with the Guidelines framed by the NCTE. Accordingly, Government of Telangana State has issued guidelines for conducting Teacher Eligibility Test vide. G.O. Ms.No. 36, School Education (Training) Department, Telangana State dated: 23.12.2015, G.O. Ms.No.8 School Education (Ser.III) Dept., dt 23.03.2022 and G.O. Ms.No.18 School Education (Ser.III) Dept., dt 05.07.2024, G.O. Ms.No.24 School Education (Ser.III) Dept., dt 08.07.2025 and G.O. Ms.No.28 School Education (Ser.III) Dept., dt 13.11.2025
- iii. The rationale for including the TET as a minimum qualification for a person to be eligible for appointment as a teacher is as under.
- i. It would bring national standards and benchmark of teacher quality

in the recruitment process;

- ii. It would induce teacher education institutions and students from these institutions to further improve their performance standards;
- iii. It would send a positive signal to all stakeholder that the Government lays special emphasis on teacher quality.

## 5. SCHEDULE OF EXAMINATION

TGTET-June-2026 shall be conducted Online as Computer Based Test (CBT) on the dates as given below in Two sessions per day.

Paper-wise detailed schedule shall be notified later.

## 6. ELIGIBILITY CRITERIA FOR CANDIDATES FOR APPEARING AT TGTET:

The candidates at the time of applying for TGTET should be in possession of the following minimum qualifications prescribed for category of I to V classes (Paper- I) and VI to VIII classes (Paper - II) separately.

### MINIMUM QUALIFICATIONS FOR TGTET PAPER-I (CLASSES I TO V):

- (i) Intermediate / Senior Secondary (or its equivalent) with at least 50% marks. However, in case of SC/ST/BC/Differently abled candidates, the minimum marks shall be 45%. **AND** pass in 2 - year Diploma in Elementary Education / 4-year Bachelor of Elementary Education (B.El.Ed.) / 2 - year Diploma in Education (Special Education).

OR

- (ii) Intermediate / Senior Secondary (or its equivalent) with atleast 45% marks. In respect of SC / ST / BC / Differently abled candidates, the minimum marks shall be 40%. **AND** pass in 2 - year Diploma in Elementary Education / 4-year Bachelor of Elementary Education (B.El.Ed.) / 2 - year Diploma in Education (Special Education) in case of the candidates who have passed or admitted to D.El.Ed / D.Ed., course prior to issue of guidelines dt. 23-12-2015.

### MINIMUM QUALIFICATIONS FOR TGTET PAPER - II (CLASSES VI TO VIII):

- (i) B.A./B.Sc./B.Com., with at least 50% marks. In case of SC/ST/BC/Differently

abled candidates, the minimum marks shall be 45%. **AND** pass in Bachelor of Education (B.Ed) course / Bachelor of Education (B.Ed -Special Education).

OR

- (ii) B.A./B.Sc./B.Com., with at least 50% marks. In respect of SC/ST/BC/Differently abled candidates, the minimum marks shall be 40%. **AND** pass in Bachelor of Education (B.Ed) course / Bachelor of Education (B.Ed -Special Education) in case of the candidates who have passed or admitted to B.Ed., course prior to issue of guidelines dt. 23-12-2015.

OR

- (iii) 4-year B.A.Ed / B.Sc.Ed., with at least 50% marks, in case of SC / ST / BC / Differently abled candidates, the minimum marks shall be 45%.

OR

- (iv) Graduation with language concerned as one of the optional subjects OR Bachelor of oriental language (or its equivalent) OR Graduation in literature OR Post Graduation in language concerned **AND** Language Pandit Training Certificate / B.Ed with language concerned as one of the Methodologies, in respect of Language Teachers.

OR

- (v) B.E/B.Tech with at least 50% marks. In respect of SC / ST / BC / Differently abled candidates, the minimum marks shall be 45% and Pass in Bachelor of Education (B.Ed.) or B.Ed. (Special Education).

**Note:**

1. The candidates, who are appearing for the final year of Bachelor of Education OR Diploma in Elementary Education etc., are also eligible to appear for TGTET Examination subject to the condition that the candidates cannot appear for Teacher Recruitment Test with this TGTET certificate, unless the candidate acquires requisite qualification.
2. A Diploma / Degree course in Teacher Education recognized by the National Council for Teacher Education (NCTE) only shall be considered. However, in case of Diploma in Education (Special Education) and B.Ed. (Special Education), a course recognized by the Rehabilitation Council of India (RCI) only shall be considered.
3. Intermediate qualification of Board of Intermediate Education (BIE) of Telangana State or its equivalent as recognized by BIE, Telangana State only shall be considered. So also, the Bachelor's Degree of a University Recognized by UGC only shall be considered.

4. Government vide Memo 2181/Ser-I/A2/2022 Dated 09-06-2017 informed that “the Govt. may impose additional qualifications over and above these qualifications specific to a teachers’ post at the time of the Notification for Teachers Recruitment Test / District Selection Committee”

**7. TET for in-service teachers:**

- i. All in-service Teachers working in Government, Local Authority and Private (Aided and Unaided) management Schools are permitted to appear for TGTET conducted by the State government or CTET conducted by the Central Government.
- ii. Secondary Grade Teachers and LFL Head Masters working in Government and Local Body Schools appointed with both D.El.Ed. and B.Ed. qualification are permitted to appear for Paper I
- iii. School Assistants, Language Pandits and Head Masters of High Schools are permitted to appear for Paper II

**8. STRUCTURE AND CONTENT OF TGTET:**

The structure and content of the TGTET is given in the following paragraphs. All questions will be Multiple Choice Questions (MCQs), each carrying one mark, with four alternatives out of which one answer will be correct. There will be no negative marking.

**(a) Paper- I: No. of Multiple-Choice Questions (MCQs) – 150**

**Duration of Examination: 2 hours and 30 minutes**

Note (1): The test items on Child Development & Pedagogy will focus on Educational Psychology of teaching and learning relevant to the primary level.

Note (2): **How to choose language – I of TGTET Paper-I:** The following 8 languages are offered under first Language in schools under State Syllabus viz., Telugu, Urdu, Hindi, Bengali, Kannada, Marati, Tamil and Gujarati. A Candidate has to choose one of these 8 languages under Language-I of TGTET and those candidates should have compulsorily studied that language either as medium of study or as first language at least up to Class X. The candidates who studied CBSE/ICSE curriculum can choose the language which they have studied up to Class X.

Note (3): The Language-II shall be English for all candidates.

Note (4): The syllabi for Mathematics & Environmental Studies are designed on the basis of topics of Classes I to V. The difficulty standard as well as linkages of content/topics could be up to Secondary Stage (up to Class X) for testing. The test items in Mathematics and Environmental Studies will contain Multiple Choice Questions (MCQs) on content and Pedagogy. In Mathematics 24 MCQs will be on Content and 6 MCQs on Pedagogy. Similarly in Environmental Studies 24 MCQs will be on content and 6 MCQs on Pedagogy.

Note (5): The syllabi for Language I & II shall be based on Proficiency in the Language, Elements of language, Communication and Comprehension abilities (standard up to Class X level).

Note (6): In 30 MCQs under Language I & II, each shall include 6 questions on Pedagogy of a Language.

Note (7): The detailed syllabus for all subjects shall be designed by the SCERT and the same shall be issued along with Notification.

Note:(1) The test items on Child Development & Pedagogy will focus on Educational Psychology of teaching and learning relevant to the elementary level.

Note:(2) **How to choose language – I of TGTET Paper-II:** The following 7 languages are offered under first Language in secondary schools under State Syllabus viz., Telugu, Urdu, Hindi, Kannada, Marathi, Tamil and Sanskrit. A Candidate (other than language pandit candidate) has to choose one of these 7 languages under Language I of TGTET and those candidates should have compulsorily studied that language either as medium of study or first language at least up to Class-X. The candidates who studied CBSE/ICSE curriculum can choose the language which they have studied up to Class X. Language pandit candidates have to choose the language of their study in pandit training concerned under language-I of TGTET Paper-II.

Note (3): The Language-II shall be English for all candidates.

Note (4): For Paper II Mathematics & Science sections, questions will be as follows:

- (i) Mathematics - 30 MCQs (Content 24; Pedagogy 06)
- (ii) Science - 30 MCQs (Content 24; Pedagogy 06)
  - a) Content - Physical Science - 12MCQs
  - b) Content - Biological Science - 12MCQs
  - c) Science Pedagogy - 06MCQs.

Note (5): For Paper II Social Studies, the syllabus will cover the sections/areas namely, History, Geography, Civics and Economics. Out of 60 marks, 48 will be on content and the remaining 12 on Pedagogy.

Note (6): For Paper II, the syllabi for TGTET of Mathematics & Sciences, Social Studies are based on topics of Classes VI to VIII. The difficulty standard of questions as well as their linkages could be up to Senior Secondary Level (12<sup>th</sup> class).

Note (7): The syllabi for Language I & II shall be based on proficiency in the language, elements of language, communication and comprehension abilities (standard up to Senior Secondary Level - 12<sup>th</sup> Class).

#### 9. MEDIUM OF QUESTION PAPER:

The question paper shall be bilingual i.e. English followed by the Language-I chosen by the candidates for all languages except Sanskrit. For the candidates choosing Sanskrit, the questions shall be in Telugu followed by Sanskrit (Devanagari script).

**10. QUALIFYING MARKS IN TGTET, ISSUE OF MEMOS/CERTIFICATES**

(i) The percentage of qualifying marks for different categories are as shown below:

S.No	Category	Pass Marks
1	General / EWS	60% and above
2	BCs	50% and above
3	SC / ST / Differently abled	40% and above

(ii) The Director, SCERT and the Member Convener, TGTET shall issue Memos/Pass certificates to the candidates.

(iii) The rules issued from time to time by the Department of Disabled Welfare shall be followed in respect of special representation for differently abled (Physically challenged) persons.

**11. VALIDITY OF TET CERTIFICATE**

The validity period of TET qualifying certificates for appointment, unless otherwise notified by the Government of Telangana, would remain valid for life.

**12. APPLICABILITY**

TGTET shall apply to all schools referred to in clause (n) of Section 2 of the RTE Act. However, a school referred to in sub-clause (iv) of clause (n) of Section 2 of the RTE Act may exercise the option of considering either the TET conducted by the Central Government or the TGTET.

**13. WEIGHTAGE OF TGTET SCORES IN THE TEACHER RECRUITMENT OF THE STATE:**

TET score shall have 20% weightage in Teacher Recruitment Test in the State of Telangana.

However, mere qualifying the TET would not confer a right on any person for recruitment / employment as it is only one of the eligibility criteria for appointment.

**14. LEGAL JURISDICTION:**

All legal disputes with regard to conduct of TET shall be subject to the jurisdiction of the courts located in the State of Telangana only.

**15. Examination Centers for TGTET-June-2026:**

TGTET-June-2026 shall be conducted Online as Computer Based Test between

15.06.2026 and 30.06.2026. Candidates can submit order of preference of the examination centers (district) given in the online application form. However, Convenor, TGTET-June-2026 has the discretion to allot candidates to the examination districts depending on the capacity of any particular district.

#### 16. **MODE OF SUBMISSION OF APPLICATION**

A candidate can apply for the TGTET-June-2026 Online by logging to the website <https://schooledu.telangana.gov.in> only. Before applying online, candidates shall ensure to have separate scanned images of latest photograph and signature in \*.jpeg format only for uploading. The candidates are not required to send hard copy of confirmation page to TGTET Cell. However, the candidates are advised to retain the hard copy of the application.

#### 17. **HALL TICKET**

Candidates can download their Hall Tickets from the website at <https://schooledu.telangana.gov.in> from 09.06.2026. In case any candidate could not download the Hall ticket she/he should contact the Director, SCERT & Ex-officio Director, TGTET, Hyderabad between 10.30 AM and 5.00 PM on all working days between 09.06.2026 and 30.06.2026 (or earlier depending on the last date of exam) in person only, giving details of the journal number of the fee paid, candidate ID of the application submitted, a copy of the printout of the Application form and one photograph (same photograph as pasted on the application form). Request for issue of duplicate Hall Ticket will not be entertained after the examination in any case.

#### 18. **PUBLISHING OF THE INITIAL KEY AND FILING OF OBJECTIONS**

- i. The Director of School Education and Chairperson, TGTET is the competent authority to publish the initial key of the question papers after the conduct of CBT inviting objections through online, if any, from the candidates who appeared for the CBT, duly giving a reasonable time to the candidates for filing objections on the initial key and the same shall be disposed of by the expert committee constituted by the Director of School Education and Chairperson, TGTET. The final key shall be published for the information of candidates. **Any representation / petition / objection on the key after the above stipulated period shall not be entertained.**
- ii. The Director of School Education and Chairperson, TGTET is authorized to dispose of the Computer Based Test information relating to TGTET-June-2026 after one year from the date of declaration of results. Request for furnishing any information relating to Computer Based Test (CBT) after the prescribed period will not be entertained.

**19. EXAM FEE:**

The exam fee prescribed for appearing for TGTET-June-2026 for General & BC candidates is Rs. 750/- (Rupees Seven Hundred and Fifty only) for either only Paper I or only Paper II and Rs.1000/- (Rupees One Thousand Only) for those appearing for both Papers I and II. For SC / ST / PwD candidates the exam fee would be Rs.700/- for one paper and Rs.950/- for two papers. Candidates can pay the exam fee through Online payment option provided at the website <https://schooledu.telangana.gov.in> from 15.04.2026 to 30.04.2026.

**20. PROCEDURE FOR ONLINE SUBMISSION OF APPLICATION**

- a. The candidate should first download the 'Information Bulletin', free of cost from the TGTET website <https://schooledu.telangana.gov.in> and verify his / her eligibility for TGTET-June-2026.
- b. The candidate after satisfying herself/himself about the eligibility criteria for TGTET, General & BC candidates shall pay a fee of 750/- (Rupees Seven Hundred and Fifty only) if appearing for a single paper (i.e., only Paper I or only Paper II) or Rs.1000/- (Rupees One Thousand only) if appearing for Both Papers (i.e., Paper I and Paper II). SC / ST / PwD candidates shall pay a fee of Rs.700/- for one paper and Rs.950/- for two papers. Candidate can pay the Fee through Online payment options provided on the website <https://schooledu.telangana.gov.in> from 15.04.2026 to 30.04.2026 for submission of application Online.   - b) Click on Application Submission.
  - c) Enter your Journal Number, Date of Payment, Date of Birth given at the time of Online payment.
  - d) Click on "Proceed to fill Application".
  - e) The application will be opened.
  - f) When the application form is opened, Fill all the mandatory fields
  - g) Click on "Preview" button provided in the bottom of the form for preview before submitting the application.
  - h) If you find all the details correct, press **SUBMIT** for final submission.
  - i) On clicking the "Submit" button the candidate application will be freezed. 'Please ensure that all the details are filled in properly. Application cannot be edited after final submission.'
  - j) Candidate will get an SMS to the registered mobile number.
- h. **After successful submission of application form online, the candidate shall preserve the details of payment ID, Journal number etc., carefully** for any kind of future correspondence.
- i. On completion of submission, the candidates shall take a printout of the application and store it for future use. Candidates should not post the printout of the application to TGTET Cell.
- j. In case of any clarification before or during or after submission of Application Online, the candidates may contact the Help desk Numbers from 15.04.2026 to 31.07.2026 on all working days.

- l. In any case applications will not be received in any kind of manual form.
- m. The candidates can download the Hall Ticket from the website <https://schooledu.telangana.gov.in> from 09.06.2026 onwards and appear for the examination at the given Centre. In case of any discrepancy noticed in Hall Ticket regarding particulars of candidate, photograph and signature or any other information he/she may immediately contact TGTE Cell for necessary corrections. In case the candidate could not download the Hall Ticket, he/she should contact the Director, SCERT & Ex-officio Director, TGTE in the O/o SCERT, Opp. L.B.Stadium E Gate, Basheerbagh, Hyderabad – 500001 between 10.30 A.M. and 5.00 P.M. on all working days between 09.06.2026 and 30.06.2026 (or earlier depending on the last date of exam) in person along with proof such as Journal Number of the fee paid, Payment reference ID of the application submitted, a copy of the printout of the Application form and one photograph (The photograph should be similar to that of the photograph downloaded in the application form).
- n. Request for issue of duplicate Hall Ticket will not be entertained after the examination in any case.

**Conditions:**

- Fee once remitted shall not be refunded under any circumstances.
  - It is to be noted that if a candidate has been allowed to appear in the Telangana State Teacher Eligibility Test, it does not imply that the candidates' eligibility has been verified. Further, qualifying the TGTE would not confer a right on any person for recruitment / employment as it is only one of the eligibility criteria for appointment. The eligibility including pass in TGTE shall be, finally, verified by the concerned recruiting agency/ appointing authority.
  - Furnishing of **false, wrong or inaccurate information may lead to cancellation of the test result** and even prosecution in appropriate cases.
  - No request for re-checking, re-assessment, re-evaluation of answer-sheets will be entertained.
21. **Procedure for Conduct of Computer Based Test (CBT) Examination of TGTE-June-2026:**

Procedure of conduct of Computer Based Test (CBT) of TGTE-June-2026 is as given under. Candidates are advised to go through the following instructions carefully before going for the Examination:

- a. The candidates should adhere to the instructions given on the Hall Ticket

Further, the candidate must show, on demand, the Hall Ticket for admission in the examination room / hall. A candidate who does not possess the Hall Ticket issued by the TGTET Office shall not be permitted for the examination under any circumstances by the Test Centre In-charge.

- b. Total duration of examination is 150 minutes (2½ hours). The timer is provided on the top right corner of the screen. After commencement of the examination, the remaining time for the examination is shown on top right corner of the screen. Examination will be over once the countdown timer reaches zero.
- c. Candidate shall not under any circumstances be permitted to the examination hall after the commencement of the examination.
- d. Subjects in the examination are displayed on the top bar of the screen. Questions in a subject can be viewed by clicking on the section name. The section that candidate is currently viewing is highlighted.
- e. Candidate can shuffle among subjects and questions any time during the examination as per her / his convenience.
- f. The Question Palette displayed on the right side of screen will show the status of each question
- g. The Marked for Review status for a question simply indicates that you would like to look at that question again. If a question is answered and Marked for Review, your answer for that question will be considered in the evaluation even if you could not Review the question for any reason.
- h. Click on the ">" arrow button to maximize the question window. To view the question palette again, you can click on "<" which appears on the right side of the question window.
- i. To answer a question, do the following:
  - Click on the question number in the Question Palette at the right of your screen to go to that numbered question directly.
  - Read the question and the Four distractors given and click on the button against the distractor you think is the correct answer for the question.
  - Click on Save & Next to save your answer for the current question and then go to the next question.
  - In case you want to review your question later, click on Mark for Review & Next to save your answer for the current question, mark it for review, and then go to the next question.
  - If a question is answered and Marked for Review, the answer for that

question will be considered in the evaluation even if the candidate could not Review the question for any reason.

- To save your answer, click on the Save & Next button.
  - To change your answer to a question that has already been answered, first select that question for answering then follow the same steps as above.
- j. Carrying of Calculators, Mathematical / Log Tables, Pagers, Cell Phones, Wrist-watches or any other Electronic Gadgets and personal belongings into the examination hall is strictly prohibited. In case, the candidate carries any personal belongings, he / she has to keep them outside the examination hall at candidate's own risk. The authorities of the test centre will not be held responsible for any loss or damage of such items.
- k. No candidate, without the special permission of the Centre In-charge or the Invigilator concerned, will leave her / his seat or Examination Room until the full duration of the paper is over.
- l. Smoking in the Examination Hall / Room is strictly prohibited.
- m. Tea, coffee, cold drinks or snacks are not allowed to be taken into the examination rooms during examination hours.
- n. The test will start exactly at the time mentioned in the Hall ticket.
- o. **Unfair Means:** Candidates shall maintain perfect silence and attend to their Question Paper only. Any conversation or gesticulation or disturbance in the Examination Room/ Hall shall be deemed as misbehavior. If a candidate is found using unfair means or impersonating, her/his candidature shall be cancelled and he/she will be liable to be debarred for taking examination either permanently or for a specified period according to the nature of offence. If any candidate is in possession of any item/s that are prohibited in the examination hall, her/his candidature for current examination will be cancelled and also liable to be debarred for future examination(s). Further TGTE is covered by ACT No.25 of 1997 of Prohibition of Malpractices in Examinations. If any candidate or any person commits any offence in Exam / Test, she / he will be liable for severe action including criminal proceedings.
- p. The candidates must sign on the Attendance Sheet at the appropriate place.

**22. ROUGH WORK:**

Blank (White) papers will be provided for rough work in the examination hall. Candidates have to handover the rough sheets to the invigilator concerned after the end of the examination.




